DESCRIPTION

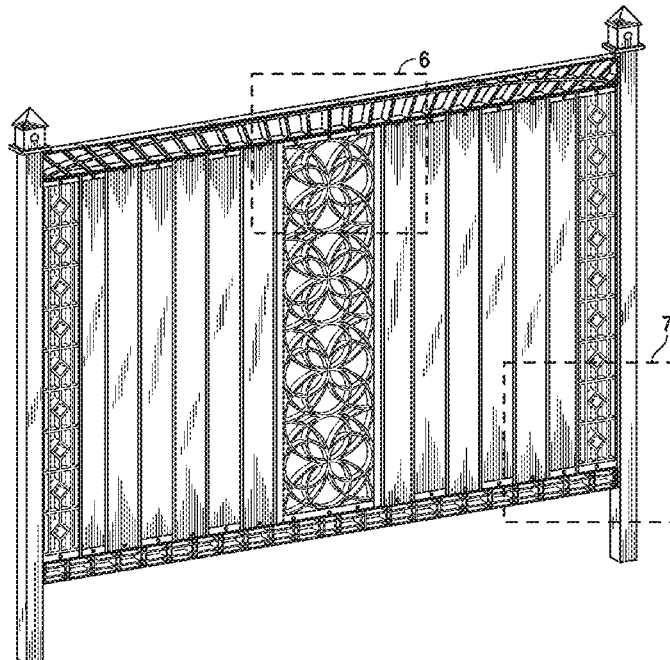
FIG. 1 is a top and front perspective view of a fence showing a new design;
 FIG. 2 is a front view thereof with the back view being a mirror image thereof;
 FIG. 3 is a left side view thereof with the right side being a mirror image thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom side view thereof;
 FIG. 6 is an expanded view from FIG. 1 thereof; and,
 FIG. 7 is an expanded view from FIG. 1 thereof.
 The dashed lines of FIGS. 1, 5 and 7 show environmental conditions only and form no part of the claimed design. The evenly spaced dashed line squares of FIGS. 1, 6 and 7 depict the limits of the enlarged views and form no part of the claimed design.

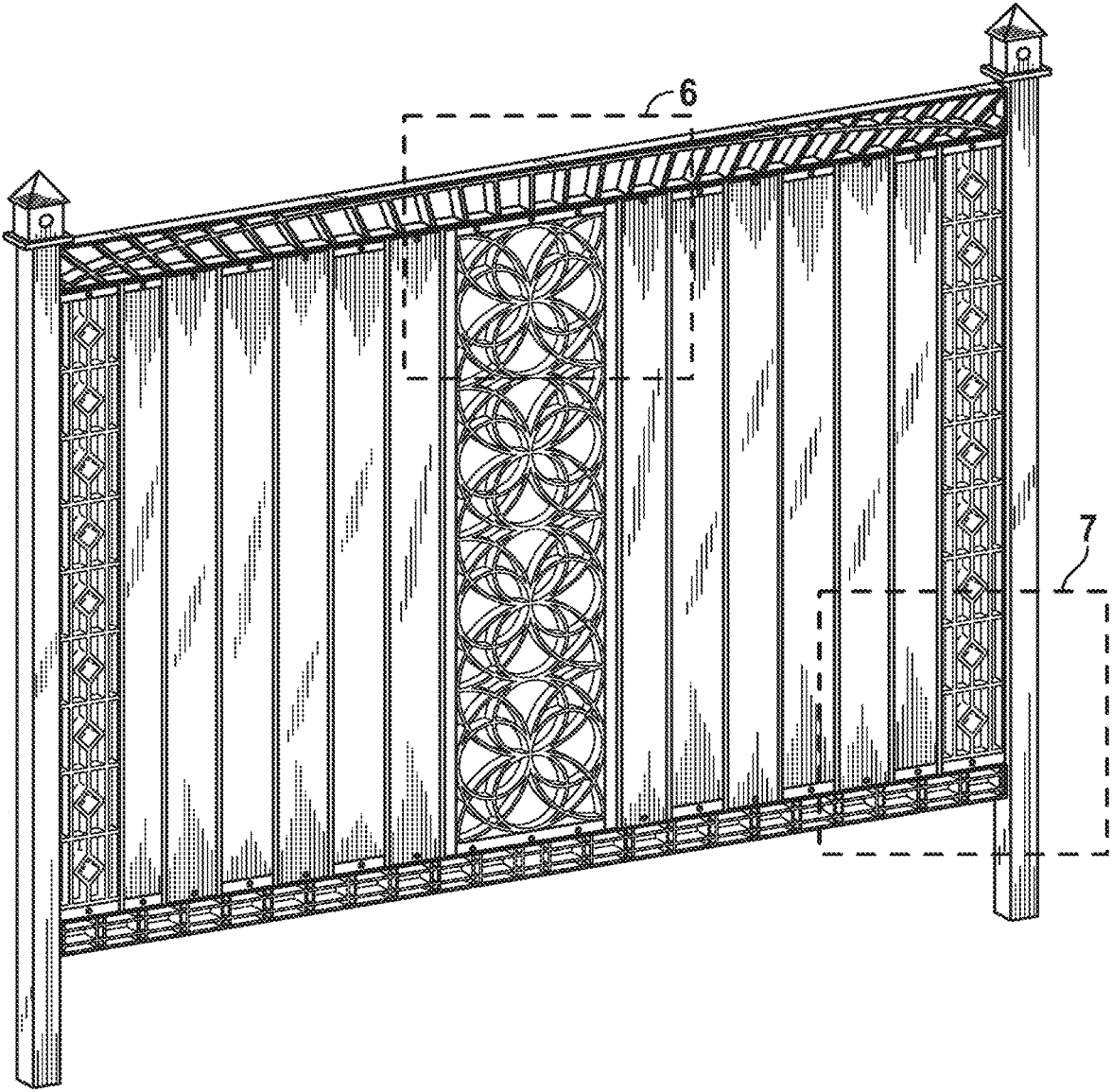

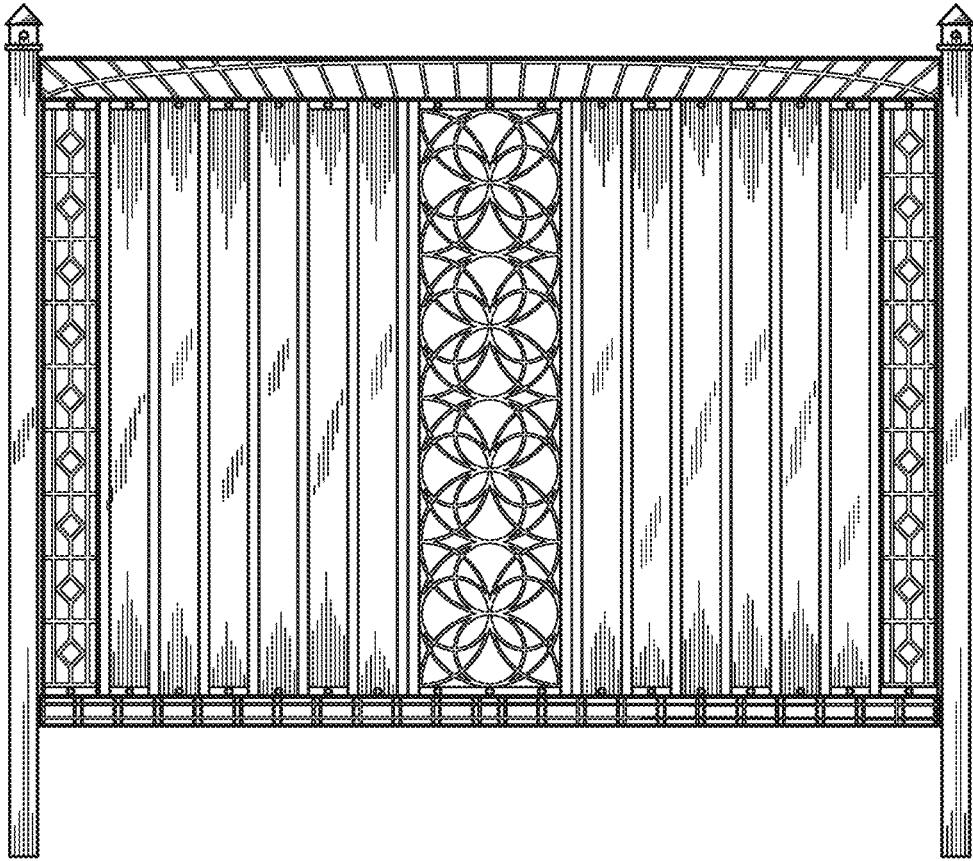

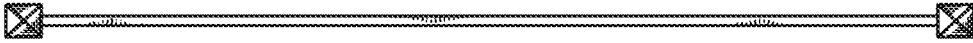

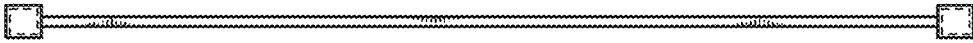

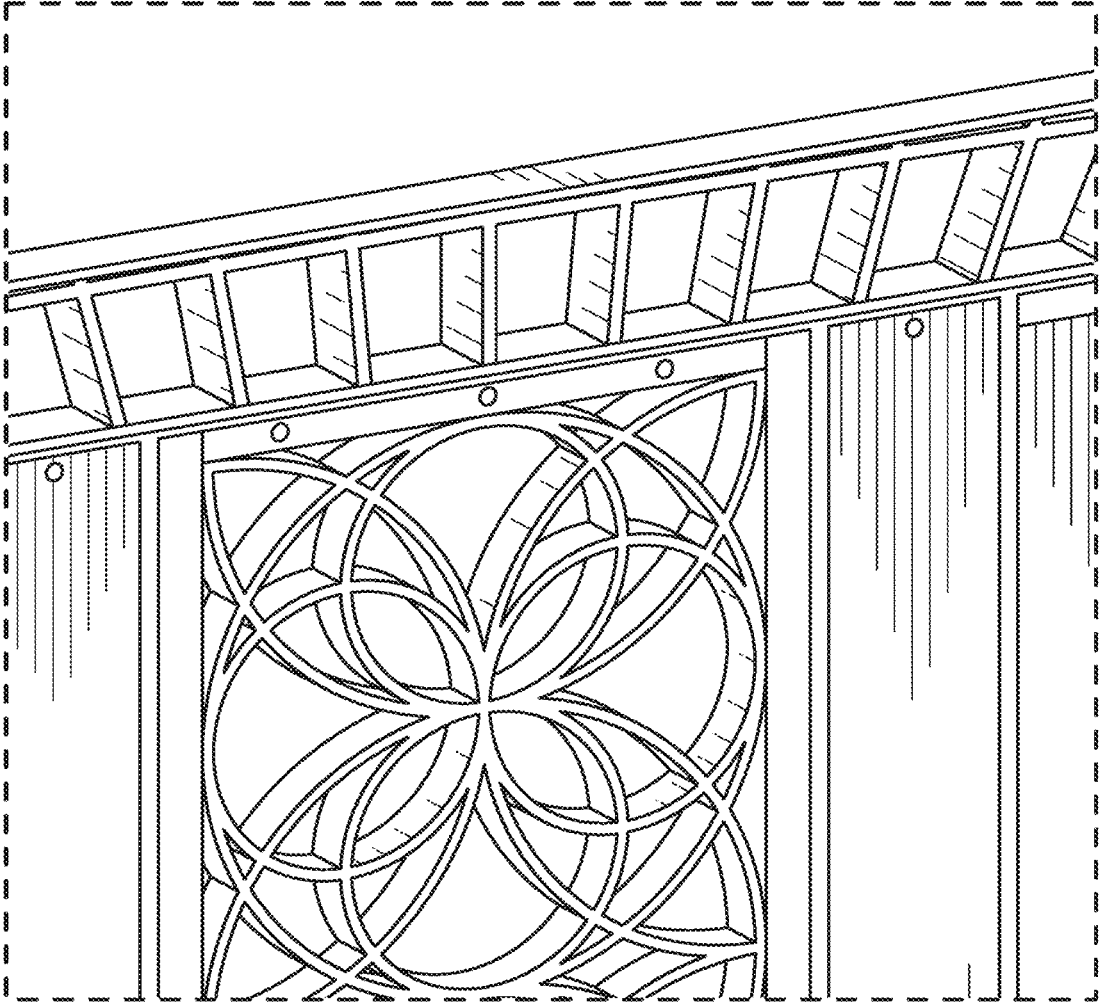

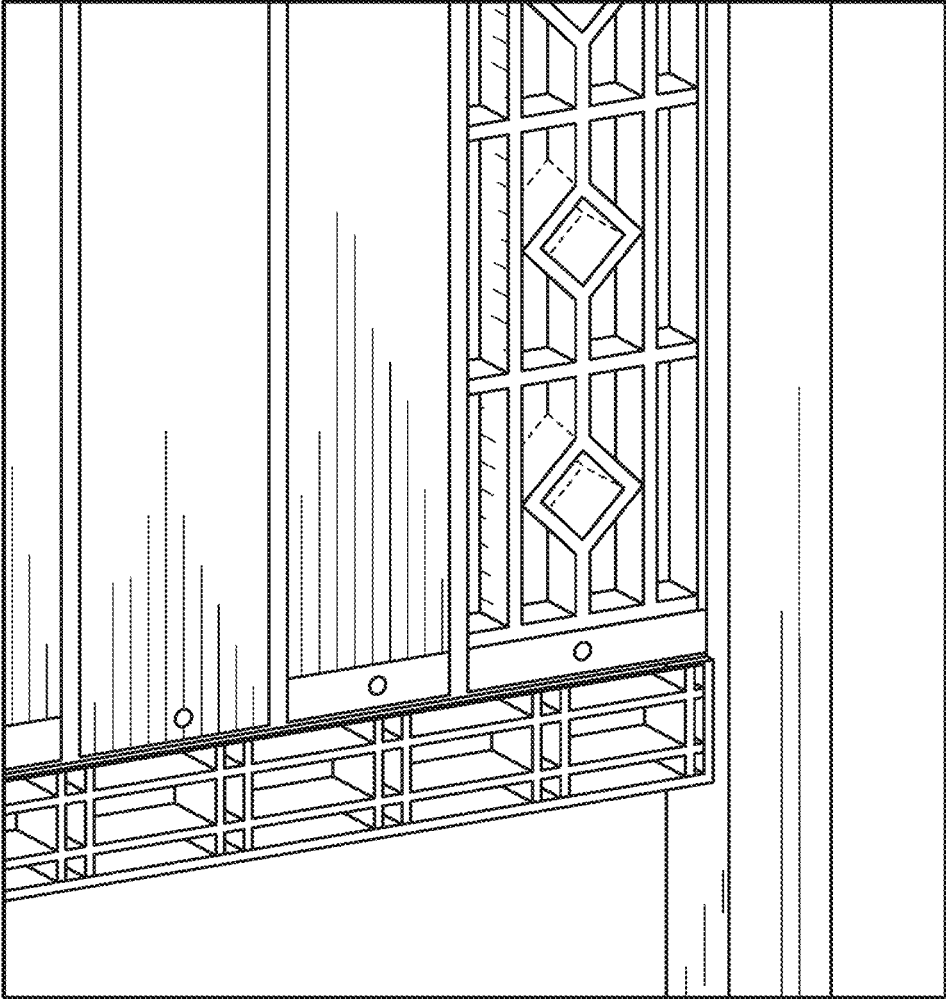
